## About Us

The Wildlife Trusts are a grassroots movement of people from a wide range of backgrounds and all walks of life, who share a set of common beliefs. It has more than 900,000 members, including 200,000 junior members, 38,000 volunteers and 3,000 staff across the federation of 46 locally independent Wildlife Trusts and the Royal Society of Wildlife Trusts (RSWT). We work in every part of the UK and on Alderney and the Isle of Man. Wildlife Trusts Wales represents the five Wildlife Trusts across Wales. Together, the 46 Trusts and the central charity are known as The Wildlife Trusts.

Wildlife Trusts have restored and care for some of the most special places for wildlife in the UK. Collectively we manage more than 2,300 nature reserves, operate 123 visitor and education centres and own 29 working farms. We undertake research, we stand up for wildlife and wild places under threat, and we help people access nature.

The next 10 years will be critical in determining what kind of world we will all live in. We need to urgently reverse the loss of wildlife and put nature into recovery at scale if we are to prevent climate and ecological disaster. It will require key stakeholders and the public to take action for nature's recovery. This will require big, bold changes in the way we think and operate, and the development of a strong, collaborative culture. We have already made great strides in the development of our marine policy, and we are now ready to build on.

If you are a passionate marine conservationist looking for a role that will deliver significant benefits for wildlife and nature across Wales with one of the UK's best-loved nature charities, then we have an exciting opportunity for you.

We are the largest non-governmental organisation working on marine in the UK, and are looking for a supportive, enthusiastic and knowledgeable colleague to join our team. ## Job Description – Overall Purpose

- **To support the Wildlife Trusts Wales Director in developing marine restoration programme for Wales including campaigns to achieve a marine environment rich in wildlife. This post will support the WTW work by developing and facilitating a greater awareness of our vision for our seas by 2030, by securing support for strong policies and effective action.**

## Job Description – Main Responsibilities

- **To lead on marine restoration programmes for WTW:**
  - Lead on the development of marine restoration programmes in Wales.
  - Contribute to the development of Wildlife Trusts positions and advocacy on related restoration programme issues.
  - Work with the RSWT Marine Conservation team to influence partners to ensure that our marine protected areas are managed and monitored.
  - Provide support to Trusts in understanding and influencing marine restoration in Wales.
  - Co-ordinate positions with Welsh Trusts and relevant Working Groups.
  - Ensure restoration developments are tracked, and key personnel alerted to potential opportunities or issues.
  - Advocate on marine work to the Welsh Government.
  - Work with Wildlife Trust colleagues across the UK and other NGOs to ensure key messages and policy positions, and approaches are aligned wherever possible.
  - Work closely with Wildlife Trust staff delivering practical activities to help showcase best practices and develop learnings for future policy and advocacy.





## Job Description – Main Responsibilities

- **To develop and manage relations with a range of stakeholders and advocates, including marine renewable sector and fisheries representatives, to build, shape and deliver restoration work in Wales:**
  - Identify key partners and stakeholders and manage agreed relationships.
  - Support the development and maintenance of networks of partner organisations.
  - Prepare briefing papers and attend key meetings as requested with Welsh Trusts.
  - Seek opportunities to trail new approaches.
  - Work with Wildlife Trust colleagues on advocacy approach.
  - Ensure the CRM is kept updated in relation to key contacts.
- **Develop a greater awareness of the marine environment internally and externally to secure support for strong adequate action:**
  - Work closely with staff in Welsh Trusts and RSWT Communications and Campaign teams, delivering communications and public engagement to build public and political support for our marine priorities.
  - Follow bilingual policy and promote the use of the Welsh language.
- **All staff are ambassadors for the organisation both internally and externally and are expected to act in a professional manner at all times. They are required to abide by organisational rules, policies and procedures as laid down in the staff handbook, adopt environmentally friendly working practices, set and maintain high personal standards of efficiency and customer care and foster a 'can do' culture based on ownership, initiative, teamwork and exchange of information..**
