


About Us








Job Description – Overall Purpose

Influence offshore wind and marine renewables development policy and the marine spatial planning process to improve the quality of decisions taken at a project and strategic level to deliver The Wildlife Trusts' belief that development in the marine environment should be right technology in the right place and not at the expense of the natural environment.

Job Description – Main Responsibilities

- Support the Marine Planning Manager to press for greater environmental sustainability of marine renewable developments.
- Influence marine renewables including offshore wind energy developments through all stages of the planning process.
- Respond to consultations and pro-actively promote any necessary policy changes to government.
- Take a lead on specific policy areas depending on area of expertise
- Facilitate action by individual and groups of Wildlife Trusts by providing support, advice, resources and training.
- Work closely with colleagues at country, regional and local level to encourage and coordinate their input to marine spatial planning work.
- Keep abreast of developing issues relevant to marine spatial planning, marine protected area designation and renewable energy in the marine environment.
- Provide support, advice, resources and training to individual Wildlife Trusts to facilitate engagement in offshore renewable development and marine spatial planning work.







Job Description – Main Responsibilities

- Develop a greater awareness of the marine environment internally and externally, in order to get support for strong policies and adequate action on the ground.
- Ensure excellent communication across the partnership in relation to marine conservation.Respond to consultations and pro-actively promote any necessary policy changes to government.
- Seek and develop opportunities to champion marine biodiversity both internally and externally.
- Support delivery of RSWT Living Seas advocacy plans.
- To increase knowledge about and raise the profile of the marine environment around the UK coast and offshore.
- To press for the good management of Marine Protected Areas, and the wider seas through Good Environmental Status in UK waters.

Occasional travel may be required within the UK.

In order for the organisation to work effectively you may be required to assist with other areas of work and therefore, you should be prepared to undertake other duties appropriate to the post, and any other reasonable duties required.

All staff are ambassadors for the organisation both internally and externally and are expected to act in a professional manner at all times. 
